WTS SW Ohio hosts Southwest Ohio Regional Transit Authority

The WTS SW Ohio Chapter kicked 2018 off with a jam packed program at McCormick & Schmick's in downtown Cincinnati. Brandy Jones, Director of External Affairs at the Southwest Ohio Regional Transit Authority/Metro, presented the Reinventing Metro Conceptual Plan outlining concepts for transit improvements that are possible if new sales tax funding is secured through Hamilton County. The objectives of the plan are financial sustainability, more frequent service, longer hours of operation and shorter trip times. Brandy discussed current challenges, demographics of ridership, and long range goals of better connecting people to jobs, including four potential BRT routes.

Cook County Shares Details of their Successful *Invest in Cook* grant program with WTS Chicago

On January 31, 2018 the Greater Chicago Chapter hosted a robust discussion with a distinguished panel of Cook County's Department of Transportation and Highways leadership. Jennifer (Sis) Killen, María Choca Urban and Tomohiko (Tomo) Music presented on their new [Invest in Cook program](#). It is an \$8.5 million grant program to provide gap funding for the advancement of planning and feasibility studies, engineering, and construction work associated with transportation improvements sponsored by local and regional governments and private partners. The excitement surrounding this event was evident by the participation from the audience. It was the Chicago chapter's largest lunch program to date with more than 120 attendees.

WTS Columbus Chapter Hosts Annual Awards Event

The WTS Columbus Chapter hosted its Annual Chapter Recognition Awards event on February 8th to present chapter awards, recognize scholarship recipients, and announce new board members.

WTS-KC Talks Missouri Transportation Funding

Missouri State Representative Kevin Corlew discussed the overall condition of Missouri's transportation system



and its funding at a WTS-KC luncheon in February. Rep. Corlew is the Chairman of Missouri's 21st Century Transportation System Task Force, which has been tasked with making recommendations to the state legislature regarding how to pay for repairing Missouri's aging transportation infrastructure. Missouri's system is the seventh largest in the country, with nearly 34,000 miles of highways. Rep. Corlew shared the task group's findings and recommendations, including a proposal to increase the state's gas tax, one of the lowest in the country. The program was a part of WTS-KC's Learn from a Leader luncheon series.

Following the award ceremony, Brian Roper (WisDOT) emceed a panel discussion with Mary Beth Pettit (Graef USA), Heather Sackman (WisDOT), Karen Dettmer (City of Milwaukee), and Carolynn Gellings (Daar Corp) about the Lakefront Gateway I-794 Ramps at Lincoln Memorial Drive. The panel discussed their experience working with one another and on the project, which involved many challenges, including ramp relocations, maintaining vehicular and pedestrian traffic, and stakeholder coordination. The \$29 million project was a unique collaboration between the State, City and County to realign the I-794 ramps to improve access for vehicles and pedestrians and mass transit operations.
