**PROGRAM HIGHLIGHTS**

**WTS Charlotte Metro Programs for Calendar Year 2020**

WTS Charlotte Metro Chapter leadership team has been reviewing the developing situation with COVID-19 social distancing measures. In our tracking of the infection rates, we are still seeing a lot of room for concern with larger public gatherings. As a result, we have made the decision to postpone our September Mini-Series signature event to the fall of 2021. Sponsors for the 2020 September Mini-Series will have their benefits applied to the 2021 event.

In January, we hosted Iona Thomas for a conversation about gender issues in the workplace (“The Last Woman in the Room”) as part of our Annual Members Meeting. The meeting was held at the Charlotte Trolley Powerhouse and we had great attendance. On February 12<sup>th</sup>, we hosted a social at Connolly’s Loft in Uptown to coincide with the WTS International Board meeting that was taking place in Charlotte that same week, to give our local chapter members an opportunity to meet and mingle with high-profile WTS leaders from across the country.

Around twenty members and WTS supporters were able to come out to take advantage of the opportunity to socialize.

At our recent Annual Meeting, our Scholarship Chair, Michelle Nance, presented our Chapter’s nominees for the WTS International Foundation Scholarships.

Adalie Harrison, a Senior at East Rowan High School, was nominated for the TRANSPORTATION YOU High School Scholarship. She is captain of the basketball team, Rowan County runner of the year, and has an interest in how active living supports health.



Juliann Lloyd, an undergraduate at Clemson University in Civil Engineering, was nominated for the Molitoris Leadership Scholarship and Sharon D. Banks Memorial Undergraduate Scholarship. She is the founding chair of the civil engineering student advisory council and helped launch a departmental mentoring event. She’s done extensive research on roundabout conversions and plans to pursue a Ph.D. in transportation engineering.

Wen Zhang, a Ph.D. student at UNC Charlotte, was presented with our Chapter’s local scholarship award, the Mary N. Clayton Honorary Scholarship, by WTS Charlotte Metro Chapter Board member Mary N. Clayton. Wen was also nominated for the WTS International Helene M. Overly Memorial Scholarship. She studies philosophy and mechanical engineering to supplement her undergraduate degrees in transportation engineering and applied mathematics. She’s worked with the NC Motorsports and Automotive Research Center linking biology and animal behavior to driver behavior, and conducted research into how to evaluate driver spontaneity during a crash as a means towards improving autonomous driving algorithms.
