## PROGRAM HIGHLIGHTS:

Presentation and tour of a local LEED Platinum Building
Optima Engineering
March 16, 2010



Thank you to Optima Engineering for allowing us to tour your LEED Platinum Facility. We learned about *sustainable design principles* and saw the facility's "green" design elements, including a rooftop look at the solar photovoltaic system and a solar water heating system. In 2009, Optima Engineering earned

Platinum Leadership in Energy and Environmental Design (LEED®) certification from the U.S. Green Building Council for its office. The

Platinum LEED rating for commercial interiors is the highest rating available, and Optima Engineering is the **first** to achieve this designation in the Charlotte area.

LEED points are awarded in five key areas: sustainable site development, water sav-

ings, energy efficiency, materials selection, and indoor environmental quality. The U.S. Green



Building Council offers four levels of LEED certificates (Certified, Silver, Gold and Platinum).

Optima Engineering's solar photovoltaic (PV) system is an array of forty 216 Watt photovoltaic modules mounted on the roof, with two 5 KW inverters in the electric room. The PV system will supply power to the utility grid, with the power being purchased by NC Greenpower. When



used in conjunction with lighting controls and daylighting, Optima Engineering's PV system is sized to produce power to equal or exceed the power consumed by the lighting and personal computers (one on each desk) during peak solar episodes.

The shell building utilizes an evacuated tube style thermal solar water heater to

provide hot domestic water for the entire building, including the core toilets and showers in the parking garage for the bike riders.



### **Transportation Summit**

April 16, 2010

The Charlotte Chamber hosted the 8th annual Transportation Summit on April 16. The summit focused on the concept of regional transportation planning. Areas of the country that have seen success in the regional transportation planning arena shared their stories with attendees. Business leaders, along with city and state officials, discussed the possibility of creating an entity in the Charlotte region. Additional updates included the airport and intermodal rail project, local and state roads and Charlotte's transit system.

The Transportation Summit is a chance for members to examine and learn about the future of Charlotte transportation. Planes, trains and automobiles are the spotlight in this popular half-day summit that features local, state and federal subject experts who share the latest information on what transportation decisions are being made and how participants can impact future decisions. Former speakers and panelists at this high-level event include transportation experts from across the country, several North Carolina cabinet secretaries, state and local elected officials and business leaders.

## **NATIONAL HIGHLIGHTS:**

**2010 WTS Annual Conference – The Right Place @ the Right Time** May  $19-21,\,2010$  Washington, DC

This year's WTS Annual Conference was held in Washington D.C. and included a number of interesting sessions by federal and local policy-makers and industry leaders. Two members of our local chapter, Kelly Goforth and Kim Bereis, attended the conference. Following are some highlights from the conference.

## Keynote Speaker

The keynote address was given by US Secretary of Transportation, Ray LaHood. He announced a new partnership between USDOT and WTS focused on workforce development and encouraging women to pursue degrees in Science, Technology, Engineering, and Math (STEM) fields.

## Surface Transportation Legislation and Funding

Several key congressional staff participated in a panel discussing federal funding for transportation. Speakers emphasized the need for stability in funding in order to have predictability for long-term transportation planning. Discretionary funds are less predictable. One of the key themes was the need to get transportation on the top of the federal agenda. The general fund transfers to the Highway Trust Fund show support for transportation, but it's not sustainable. Polly Trottenburg, Assistant Secretary at the USDOT, discussed the need to focus on tracking performance for all transportation programs to build public support for additional funding. Joyce Rose, House Appropriations Committee staff, spoke about concerns that the High Speed Rail program, which awarded grants to 78 projects, spread funding too thin, instead of focusing funds on fewer projects to create results that will "capture the imagination of the public" and garner long term support for funding. To gain support, there needs to be a project to show for the investment.

## Transit's Role in Sustainability

Transit agency representatives from Washington DC, Atlanta, and Salt Lake City discussed their efforts related to sustainability policies in their areas. WMATA (Washington DC) has no adopted Board policy, but is looking to frame "sustainability" in terms of being strategic for the organization and to use it as part of workforce motivation. Performance measurement is important in terms of efficiency, energy savings, and TOD. Some of WMATA's sustainability initiatives include ISO 14001.C. recycling program, LED lit railcars (test), wayside regenerative braking, joint development, and park and ride priority for zip cars. MARTA (Atlanta) is working on sustainability from the development perspective. The agency is working on regional effort that focuses on transit's role in revitalization in a broader view, not just on the real estate deal. They are developing a set of TOD guidelines and policies using Charlotte as an example. UTA (Salt Lake City, Utah) completed a recent survey where 85% of respondents agree that "transit supports the environment" and 76% agree that "transit supports the economy". UTA's mission is about shaping community, and the agency is working in partnership with UDOT related to land use and growth strategies. Their plans call for five rail lines by 2015, supported by a 2006 referendum. The key to the referendum's success is that local leaders were champions: the Chamber of commerce advocated transit's connection to the economy by reducing congestion and improving goods movement; the University cites that 30-40% of university trips taken by transit, reduced parking deck construction. Transit agencies need to discuss all dimensions of transit benefits.

### American Streetcar Resurgence

The session on the streetcar projects in the US provided an overview of cities with existing streetcar systems, those considering streetcar projects, and highlighted projects in Portland and Arlington. Across the country, streetcar projects are being driven primarily by cities, not transit agencies. Most of the current systems are historic trolley, with three modern streetcar systems. The Portland Streetcar opened its first line in 2001. Property owners drove the project. They wanted high capacity service, not tourist oriented, which led to the procurement of a modern low floor streetcar. The streetcar has resulted in \$3.5 billion in private development: 12,000 riders/day: 10,000 housing units downtown. The Arlington Columbia Pike Streetcar project is based on a history of strong land use planning. In the 1970s, the Arlington Land Use Plan called for the Metro Orange Line to be built in the center of town not in middle of I-66 as originally proposed. The result was more balance in jobs/residents (now 50/50), and transit ridership of 250,000 per day in Arlington (200,000 Metrorail). The Columbia Pike Streetcar project is a proposed Small Start project, with a cost of \$160 million. Finally, Matt Welbes, FTA Executive Director, discussed FTA funding initiatives including Small

Starts, TIGER I, FTA Research Program, Urban circulator, and TIGER II that have awarded or will award grants for streetcar projects. He also discussed changes to the New Starts/Small Starts program that may make more streetcar projects eligible and competitive.

## Leadership Session

Four outstanding women leaders spoke about their experiences: Therese McMillan, Deputy Administrator, Federal Transit Administration; Barbara Reese, Deputy Chief Administrative Officer, City of Richmond; Pauline Schneider, Partner, Orrick, Herrington, & Sutcliffe LLP (public finance); and Lisa Mancini, Senior Vice-President, CSX Corporation. Key highlights of the Q&A:

What is leadership? Leaders enable others to do their best. They lead by experience and by example. A good leader is a good listener.

What do you look for in hiring or promoting? The top attributes mentioned were communication skills and continuous learning / natural curiosity.

Why is it a good time to be in transportation as a leader? There are challenges, but they are solvable; feel passionate about goals. Creative and sustainable ideas come from times of crisis.

What are your top 3 challenges as a leader in transportation? 1. Money/funding 2. Standing up against the quick fix and investing for the long term. 3. Finding the right work/life balance and finding time to work on the vision.


