PROGRAM HIGHLIGHTS:

Capital Projects Sales Tax Programs for Counties

How do you put 99 cents of every tax dollar on a project you choose? By taking advantage of a capital projects sales tax program in your county. At our January program, Myron George of Capital Management & Engineering (CME) in Rock Hill explained how beneficial this type of program can be.



York County in South Carolina currently has a one cent sales tax program known as *Pennies for Progress*. This program is for transportation improvements and is an excellent example of what can be accomplished with the "penny":

- 6 school access improvements
- 340 lane miles of road improvements
- 170 intersections improved
- 308 gravel roads paved (115 miles)
- 65 miles of bikeways constructed
- 40 mile multilane connector between I-77 and I-85

Growing counties are looking for ways to alleviate traffic congestion, address safety problems and deal with expected growth in the future. Infrastructure improvements are needed, but there is not enough funding to address the needs. A capital projects sales tax program can go a long way in addressing these needs, especially since sales tax funding can be leveraged to obtain matching funds. The tax is only collected for a limited number of years, and counties are able to help themselves rather that depending on assistance from state or federal funding. What a difference the "penny" makes!

MEMBER SPOTLIGHT

Brock LaForty, AICP, is the Membership Chairman for the WTS Charlotte Metro Chapter. Brock decided to join WTS to continue and grow his involvement in professional societies in the transportation field. As Membership Chair, Brock hopes to see the chapter meet their goal of 30 members in the first year and then continue to grow membership thereafter.



Brock is a Project Manager and Senior Transportation Planner for STV/Ralph Whitehead Associates in their Charlotte Office. He also serves as Planning Group Leader, overseeing a 6-person group that leads the planning and traffic analysis for all of the firm's transportation projects.

As a native of New York, Brock started his career with the Syracuse Metropolitan Transportation Council. He has also worked for Sear Brown and URS. Brock joined STV/RWA in 2002 as the firm's first certified planner, and has climbed the ranks to his current position.

Brock's skills include NEPA planning documents, feasibility studies, traffic studies/modeling, and public involvement activities. He is somewhat unique in that his skills include freight rail, mass transit, (bus and rail), and highway transportation systems. Brock is currently serving as Lead Planner for the \$750 million CATS Northeast Corridor light rail project, the largest single transportation public works endeavor in the history of North Carolina.


