Project Engineer

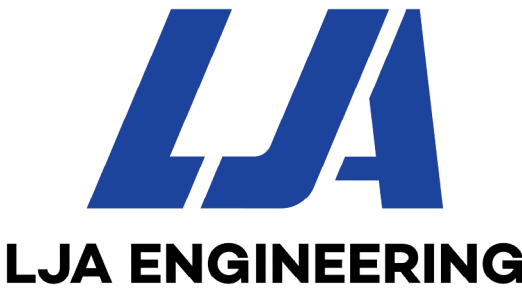

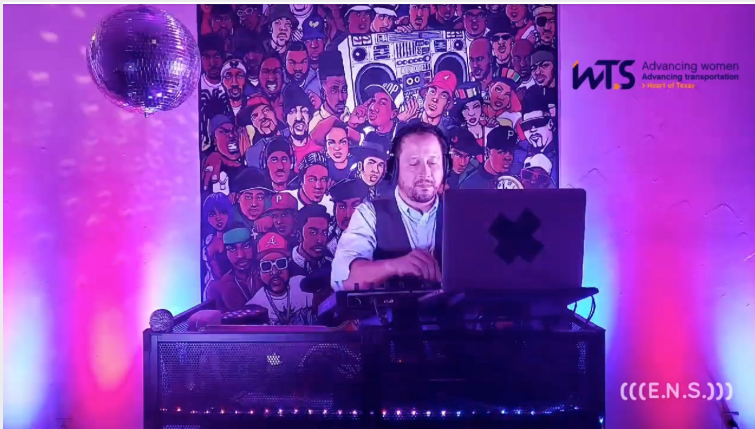




# WTS HOT CHAPTER 16TH ANNUAL SCHOLARSHIPS AND AWARDS GALA

The student members caught up at a socially distanced picnic!



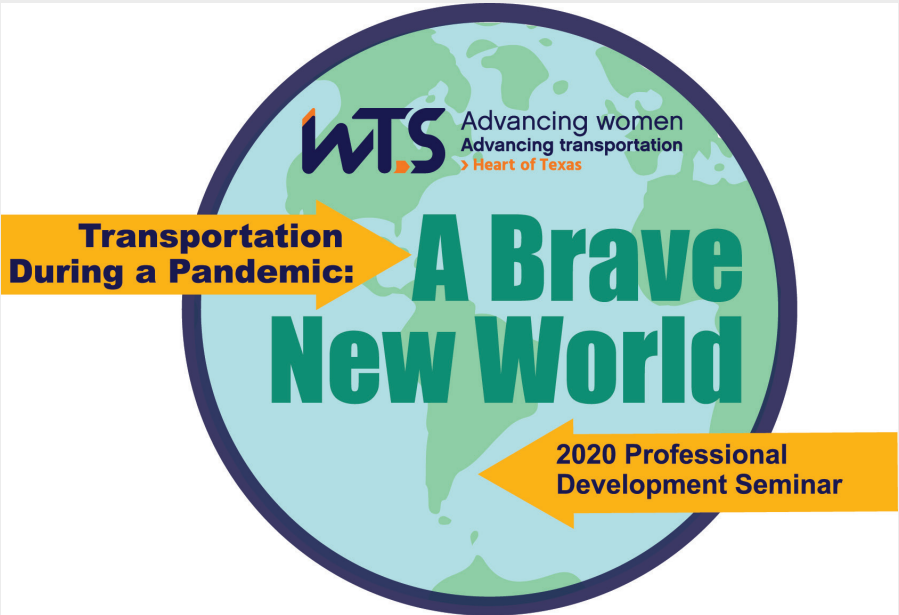

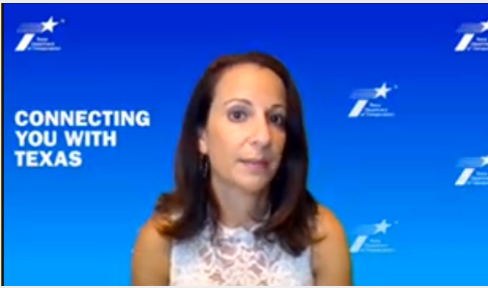

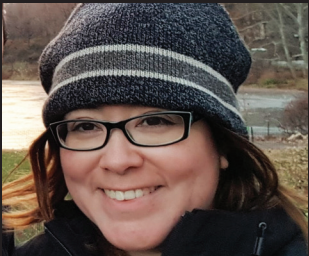
