## **ANNUAL REPORT 1985**

## Dear Members,

For nearly nine years, WTS has been recognized as one of the premier transportation organizations in Washington. This recognition comes from an enthusiastic membership supporting a broad range of program activities that strive to be tropical and informative. WTS Washington, with over 300 members, is very proud to be part of a growing national network that now has seventeen chapters and almost 2,000 members.

During 1985, the chapter made great progress in interacting with other transportation organizations in the metropolitan Washington area. The March luncheon which featured Representative James J. Florio was a very successful joint effort with the Women's Council on Energy and the Environment (WCEE). To commemorate National Transportation Week (May 12-18, 1985), WTS and six other organizations including Traffic Club of Washington; Traffic Service Corporation; American Trucking Associations; National Industrial Transportation League; and the Washington chapters of the Transportation Research Forum and the Delta Nu Alpha Transportation Fraternity produced a multimodal poster that appeared on Metrobuses and in numerous public buildings. Our October dinner meeting was co-sponsored with Delta Nu Alpha and presented the Executive Vice President, Sales and Marketing, Seaboard/Chessie System Railroads, James A. Hagen. WTS was very pleased to join with the members of these organizations and we look to continuing our relationship in the future.

At the January Anniversary party, the 1984 Annual Achievement Award was presented to Rosalind (Lindy) Knapp, Deputy General Counsel of the U.S. Department of Transportation, in recognition of her distinguished career in transportation and the contribution she has made both in shaping today's transportation policies and in leading the way for other women in our field. The Member of the Year Award was presented to Shirley Lloyd to recognize her many years of service to WTS and, particularly, her efforts as chair of the 1984 Annual Conference Steering Committee. The recipient of the WTS Congressional Achievement Award was Representative William Lehman, Chairman of the House Appropriations Subcommittee on Transportation. The award was made at our annual Congressional Reception to acknowledge Congressman Lehman for his vigorous pursuit of programs that support public transportation and the development of a rational transportation network in our country.

Our membership has stabilized and matured during the past year. We interacted with others, our programs reflected a diversity of topics and interests, and some of our members were recognized through WTS National. Sally Cooper was named WTS Woman of the Year at the Annual Conference in Boston. WTS National officers for 1985-86 include Jean Kerr, President; Judy Kaplan Wener, Secretary; and Kathy Hooper, Director-at-Large. WTS Washington is proud of the accomplishments of these members.

WTS has had a good year through the dedicated efforts of its members. On behalf of the 1985 Executive Board, I would like to extend our thanks and gratitude for all the members and friends of WTS who contributed their time and resources to making 1985 an extremely rewarding year for WTS Washington.
