President's Message

Dear WTS-DC Chapter Members and Friends,

The year 2020 provided WTS-DC with an opportunity to stretch ourselves and reexamine our priorities. As always, we are here to support the professional growth of our members and community. We also reminded ourselves how vital it is to embrace inclusion and promote equity, which are part of the [WTS vision and core values](#).

While the year started strong, the COVID-19 pandemic quickly altered how we conduct ourselves. Our typically in-person events changed to virtual events, and the same was true for our board meetings. Still, as a chapter, we hosted 16 events, all but two of which were virtual. I appreciate the agility of our board to switch event formats from being in-person to being virtual seamlessly! We persevered through these challenging times and sustained hosting valuable events for the benefit of our community.

Our event speakers included Delaware DOT Secretary Jennifer Cohan, Virginia Department of Rail and Public Transportation (DRPT) Director Jennifer Mitchell (a former WTS-DC President), and FAA's Acting Assistant Administrator for NextGen (ANG) Pamela Whitley. We had a panel event to discuss Vision Zero in the DMV in which we had the Program Coordinators from each respective jurisdiction: Christine Mayeur from Alexandria, Christine Baker from Arlington, Emily Dalphy from DC, Wade Holland from Montgomery County, and Andrea Lasker from Prince George's County. We also hosted multiple panels with local agencies to discuss how they were handling the pandemic. From VDOT, we were joined by Northern Virginia District Engineer Helen Cuervo, Mega Projects Director and Design-Build Program Manager Susan Shaw, Assistant District Administrator for Planning and Investment Maria Sinner, Acting Deputy District Administrator and Assistant District Administrator of Business Monica Bhatia, and Multimodal Transportation Planner Halie Mitchell. Our annual WMATA event was also pandemic-themed this year, and we were fortunate to be joined by WMATA General Manager and CEO Paul Wiedefeld, Executive Vice President and Chief Safety Officer (CSO) Theresa Impastato, and Vice President of Government Relations Regina Sullivan.

In addition to these impressive speakers, we held events that helped our audience improve their professional development skills, socialize, and relax. In February, we had an event discussing how to present yourself professionally. In August, we had our annual joint event with YPT-DC and TRF during which we discussed the aviation industry. In October, we spoke with two pollsters, one Republican and one Democrat, to discuss polling in the upcoming election. For fun and to virtually network, we held a transportation trivia night in June. And to help our audience destress, we held a breathwork event where participants were guided through a meditative breathwork journey set to music to breathe, feel, heal, and thrive.

No event was more of an undertaking in a virtual environment than our largest event each year—the WTS-DC Holiday Party. With a revised one-hour virtual format, we spent time highlighting important chapter activities and our commitment to positively impacting our community, promoting equity and inclusion, and supporting the next generation of transportation professionals. The evening featured the Transportation YOU program, which works with girls from three DC high schools and introduces them to the opportunities for careers in STEM fields, as well as our mentoring program, which pairs professionals with similar interests and facilitates events and discussions for them to grow in their careers. Recognition

Award winners and our scholarship recipients were also recognized. This year, we awarded \$15,500 in scholarships, which is the highest amount WTS-DC has ever distributed! I want to thank our Scholarship and Fundraising Committee for all of their work to revamp our scholarship solicitation process, which helped us receive applications from exceptional young women in the DC area who are pursuing degrees in transportation. I also want to thank the committee and the rest of the board for all of the effort to raise scholarship funds, and a big thank you to the WTS-DC community, who graciously donated money to our scholarship fund. Scholarships are a vital part of our WTS mission and provide us with an opportunity to promote diversity, equality, and inclusion among our awardees. I want to recognize Audra Bandy for leading the Holiday Party Committee and for all of the hard work she did to transition the party to be virtual, working with multiple committees to come up with an hour's worth of virtual content, and organizing the event to run so smoothly. Thank you, Audra!

Additionally, 2020 was a big year for WTS-I as a revamped brand and organizational systems rolled out. The most obvious change to many people was that we refreshed our logo and website. The new WTS logo design “echoes the forward-thinking, inspiring, inclusive nature of WTS.” The WTS tagline—“Advancing Women, Advancing Transportation”—“underscores the dual goals of the WTS mission of serving women transportation professionals and the transportation industry as a whole.” Aside from the outward-facing changes, WTS-I also changed the internal association management systems, impacting the membership database, chapter communications, event registration, and more. I am grateful to our board members who helped our chapter implement changes to all these processes and systems!

As 2020 comes to a close, I want to say a big THANK YOU to the entire WTS-DC community! The WTS-DC board and advisors have been exceptional this year, and I am so grateful to them. Everything we accomplished in 2020 is because of their dedication to the organization and their willingness to donate their free time to support our chapter's success. I also want to thank WTS-DC's corporate members, who have sustained our organization through their generous donations. Last but certainly not least, I extend my gratitude to our members and others in the WTS-DC community who choose to engage with us.

WTS-DC has embraced the changes we faced in 2020, and we look forward to supporting the DC transportation industry in 2021!

Executive Board

As President, Neela Babu guided and led the organization. She set goals and objectives for the organization in conjunction with the Executive Board and the members. Neela was also responsible for presiding at meetings and events, and for communicating with the board and the membership. In general, the president provides leadership and direction for WTS-DC and has the authority to sign official documents on behalf of the organization.



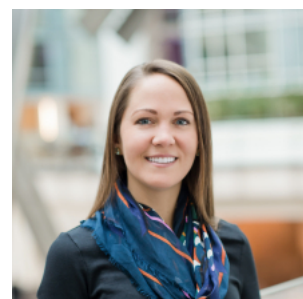

As Vice President, Katie Kraft supported the President. She was also responsible for organizing meeting invitations and sending out the agenda prior to board meetings and the annual meeting. The Vice President oversees programming for the chapter, which includes coordinating with other committees on topics, dates, times, and locations for events.

As Treasurer, Rachel Roberts had charge and custody of the WTS-DC accounts, both for the chapter and for the scholarship account. She was responsible for coordinating the budget, preparing monthly financial reports, preparing the annual financial reports, handling all donations, and maintaining financial records. In addition to the President, the Treasurer has the authority to sign contracts and invoices on behalf of the chapter.

As Secretary, Christine Sherman Baker served as the guardian of all WTS-DC Corporate records. She was responsible for keeping the minutes of all meetings and for maintaining the website. In 2020, Christine also managed the officer election process and transitioning the chapter website content to the new WTS-I system.

As Immediate Past President, Adrienne Ameal served as an advisor to the Executive Board and a historian of previous chapter activities. She was also the chapter representative to the WTS Northeast Region Council.

The Executive Board collectively works to make decisions pertaining to running the chapter. All five officers work together to check in with committees, recruit volunteers for the Board, engage with members, and act as ambassadors for WTS-DC.

Board Meetings

Due to the COVID-19 pandemic, the Chapter held the majority of its 2020 meetings virtually, via Zoom. The Executive Board and representatives from each committee were expected to attend at least eight of the 11 board meetings. For a quorum to be established, at least three of the five executive board members needed to be present and at least six of the committees needed to be represented. Committees submitted monthly committee reports before each meeting. The Treasurer also submitted the monthly report detailing the Chapter's finances. These reports were compiled along with the board meeting agenda and distributed by email prior to the meeting.

2020 Annual Meeting

The WTS-DC 2020 annual meeting was held at the start of our August 10th board meeting. The primary business of the annual meeting was to vote on the WTS-DC 2019 Annual Report and the meeting minutes from the 2019 Annual Meeting. All members were invited to attend by Zoom (due to the COVID-19 pandemic); members also had the option to vote in advance or by proxy. Once a quorum was established, the membership voted to approve the annual report. Members were invited to comment on any other business and then the meeting adjourned. 2020 Officer Elections

Every year, WTS-DC elects four officers for the following calendar year: President, Vice President, Treasurer, and Secretary. In the fall of 2020, the Executive Board presented a slate of candidates for those four positions for 2021. To facilitate anonymous voting, the election was held using an online system called Election Runner, which emailed each chapter member (who had been a member in good standing for at least 30 days prior to the election) a unique link to their ballot. The ballot listed the candidate slate and, for each position, presented the option for a write-in. Members voted for one person for each position. Per the WTS-DC bylaws, at least 10 percent of the membership must vote to establish a quorum. The response rate in the election exceeded that threshold, and the membership voted on the following officers to lead WTS-DC in 2021:

- President: Neela Babu
- Vice President: Katie Kraft
- Treasurer: Shelley Wynne
- Secretary: Katie Masetti

Adrienne Ameal will serve as Immediate Past President in 2021.

Committee Reports

WTS-DC has 12 committees that contribute to the overall functioning of the chapter. The responsibilities of each committee are described below along with a summary of their accomplishments in 2020.

The year started with an enthusiastic Strategic Planning meeting in late January. The committees assembled and set goals for the year. With the onset of the COVID-19 global pandemic in March, the committees reevaluated their goals and approaches to match the new virtual environment.

Communications, Newsletter and Social Media Committee

The Communications, Newsletter and Social Media Committee works with the Executive Board and the Chapter committees to provide regular communications to chapter members and friends. The committee has an active presence on social media as they curate content for the chapter's social media channels, including Twitter, Facebook and LinkedIn. The committee is also responsible for publishing a bi-monthly newsletter, which includes a president's message, summaries of recent events, corporate member spotlights, and other articles written by members.

In 2020, Jennifer Flanery (Stratacomm), as Chair, and Amber Garnett (Stratacomm), as Deputy Chair, led the Communications, Newsletter and Social Media Committee. The committee continued to support ongoing e-blast and e-newsletter development. This included completing the reconciliation and migration of the chapter's Constant Contact email contact lists to a new association management system (AMS) rolled out by WTS-I in Q2 and updating branding across Constant Contact email templates as WTS-DC awaited the availability of the email function in the new AMS. The committee also updated branding across the Chapter's social media platforms.

With the new AMS, the committee transitioned to hosting e-newsletter news/articles within the chapter's new [website](#). A total of five e-newsletters were sent in 2020. (We paused publishing content on the March/April newsletter with the onset of Covid-19.) The newsletters in 2020 contained a wide range of transportation-related topics, summaries of Chapter member-wide or invitation-only events, recognition of various national issues (e.g., International Day of Women and Girls in Science, and the 100th Anniversary of the Women's Vote in the United States), and recognition of members, scholarship recipients and award winners. The website above opens with the most recent articles and provides access to prior articles (since May 2020).

Lastly, the Communications Committee continued to manage and curate content for the chapter's social media channels, including [Twitter](#), [Facebook](#) and [LinkedIn](#), ensuring more consistent use of social media best practices. Analytics for these efforts are as follows:

Corporate Relations and Program Sponsorship Committee

The Corporate Relations and Program Sponsorship Committee's responsibilities for corporate membership include: developing and updating the corporate membership benefits brochure; maintaining the list of corporate members; profiling corporate members in the newsletter; recruiting new corporate members; and ensuring that the corporate membership logos and banner are up to date. Additionally, the committee is responsible for managing program sponsorships, which are donations for specific programs run by WTS-DC.

The Corporate Relations and Program Sponsorship Committee was led by Cherie Gibson (HNTB) as Chair and Shelley Johnson (Sharp and Company) as Deputy Chair. Anita Beier supported the committee as a volunteer.

Despite the global pandemic, the committee successfully maintained 2019-2020 corporate membership contribution levels, secured three Transportation Rock Stars totaling \$1,500, and recruited three new corporate members. The committee also redesigned the corporate membership brochure to recruit virtually with a focus on scholarships and virtual event benefits due to COVID-19. This year, the Chapter added a new Public Sector Agency category at the \$750 level. This level was specially created for public sector agencies who want to advance women in transportation.

Diversity Committee

The Diversity Committee's activities and efforts through the year promote the WTS-DC belief that every industry, including transportation, benefits from diversity and embracing diverse backgrounds and points of view will guide us towards more innovative and equitable transportation solutions that work for everyone.

The Diversity Committee was led by Sahar Nabaee (STV Inc.) as Chair and Rebecca Moser (Arlington County) and Anita Beier as Deputy Chairs. Alyssa Saleh (HNTB) served the committee as a volunteer.

The Diversity Committee began the year by contributing informative and thought-provoking content for the chapter newsletter. The committee prepared an [article](#) to commemorate International Day of Women and Girls in Science (celebrated on February 11), which discussed the historical barriers for women pursuing careers in STEM fields and the role of Title IX in opening new educational opportunities, and highlighted American women accomplishing “firsts” in STEM fields between 1847-2020. In May, the committee submitted an [article](#) to celebrate Asian-American Heritage Month. This article pulled occupation data from the US Census Bureau’s American Community Survey (ACS) for Caucasians, Asian Americans, African Americans, and other races. Briefly, the findings highlighted discrimination towards Asian Americans in the United States, yet in more recent decades a trend towards greater social upward mobility and a gained higher social status. Asian Americans are breaking typical immigrant stereotypes and are greatly contributing to US economic, political, and cultural life.

Due to the COVID-19 pandemic, the committee was not able to host an in-person event. To keep WTS-DC members engaged, the committee partnered with the Professional Development Committee to release a personal feedback survey during May 2020. This survey gathered information about how members were coping with the new day-to-day lifestyles of working remotely, and any financial, emotional, or personal stresses that came about as a result of the pandemic. In collaboration with the Professional Development Committee, the Diversity Committee submitted articles for the chapter newsletter that summarized the results from the survey, titled “[Voices from the COVID-19 Crisis](#)” and “[Voices from the COVID-19 Crisis: Part 2](#).”

Holiday Party Committee

The Holiday Party Committee is responsible for organizing the Chapter's largest event of the year: the Annual Holiday Party in December. The committee coordinates with several other committees to plan the event, including the Scholarship and Fundraising Committee, whose awardees are recognized at the event; the Recognitions Committee, whose awardees also are recognized at the event; the Corporate Relations and Program Sponsorship Committee, to identify potential program sponsors and coordinate with corporate sponsors regarding complimentary tickets; and the Program Logistics Committee, on ticket sales.

In 2020, Audra Bandy (Fairfax County DOT) served as Chair of the Holiday Party Committee and Sofie Rhoads (Foursquare ITP) and Sara Haley (Sullivan Strategies) served as Deputy Chairs.

With the overwhelmingly successful event held in December 2019 at the Hotel Monaco, the committee hoped to plan a “repeat” successful, in-person event in 2020. However, a global pandemic forced a complete change in plans and complete change in venue and preparation. The committee transferred its energies to planning a virtual holiday celebration to be hosted on Zoom with a combination of live speaking and pre-recorded content. The change in format required additional effort, especially to bring together the pre-recorded videos and to generally provide content for a full hour for the party. Additional volunteers stepped up to help, including Advisors Brittney Gick and Margaret Ballard. The committee worked with WTS-I to use the WTS-I Zoom account, and we were grateful to the staffers at WTS-I who supported our event. (See the “Holiday Party” section in “Events Throughout 2020” for more information.)

Legislative Committee

The Legislative Committee works to inform WTS-DC members about critical legislative issues that affect the transportation industry, and to strengthen the relationships between WTS-DC members and representatives on Capitol Hill. The committee typically hosts at least one event each year and contributes newsletter articles about legislative matters.

The Legislative Committee was led by Jennifer Covino (Simon and Company) as Chair and Kerry O'Hare (O'Hare Infrastructure Strategies, LLC) as Deputy Chair. Kate Roetzer (Washington Metropolitan Area Transit Authority) served as a volunteer.

The Committee provided two articles to the WTS-DC Newsletter. In January/February, the Legislative Update [summarized](#) the U.S. Conference of Mayors Winter Meeting, held in the nation's capital. A bipartisan delegation of U.S. mayors went to the White House to meet with President Donald Trump and other senior officials on Friday, January 24. The president highlighted infrastructure as a top priority for the administration in his remarks on “transforming America's communities” to the group. The update also addressed upcoming infrastructure proposals expected from both House and Senate committees.

In the summer, the Legislative Update covered pending infrastructure legislation in Congress in the article titled [“Where We Are With a Surface Transportation Bill During COVID-19.”](#) The Moving Forward Act (H.R. 2), which passed the House by a 233-188 vote, would support affordable housing, broadband expansion, schools, clean energy, wastewater and drinking water infrastructure, hospitals, and the U.S. Postal Service. The article explained that authorization of the Fixing America's Surface Transportation (FAST) Act of 2015 would expire on September 30, 2020. (A year-long extension was signed October 1, 2020.)

Due to the COVID-19 pandemic, the Committee did not host an on-the-Hill event in 2020. Instead, the committee organized a virtual webinar focused on the 2020 election. (See the “Election 2020” section in “Events Throughout 2020” for more information.)

Membership Committee

The Membership Committee is responsible for maintaining up-to-date membership records, preparing welcome packets for new members, sending renewal emails to chapter members, and answering any membership-related questions. They provide additional support to the Program Logistics Committee by confirming that everyone who purchased a member ticket for one of our events is a WTS member, and they support the Communications Committee to ensure that our membership email lists are up to date.

The Membership Committee was led by Bailey Lozner (Kittelson and Associates) as Chair and Lezlie Rupert (DDOT) as Deputy Chair. Danielle McCray (Kimley-Horn) provided support as a volunteer.

In 2020, the committee hoped to recreate the Membership Mixer held the prior year. However, the committee was thwarted with the pandemic and social distancing requirements. Volunteers Avital Barnea, Adrienne Ameel, and Margaret Ballard hosted a fun “Transportation Trivia” virtual happy hour in June to engage with members in a fun and social way while still being socially distant. (See “Events Throughout 2020” section below for more details.)

WTS-I offered many member initiatives in 2020. One new WTS-I initiative provides complimentary student memberships, in order to encourage more chapter participation by local colleges and universities.

WTS-DC Chapter membership remained relatively constant throughout 2020 with the average member count hovering around 212.

Mentoring Committee

The Mentoring Committee is responsible for matching industry leaders with young professionals in a mentor-mentee relationship. The committee facilitates learning experiences around professionalism in a friendly, interactive environment. In addition to the one-on-one matches, there are group events hosted by industry experts and successful professionals in various sectors of transportation to share career lessons learned.

Jacqueline Lavalleye (HDR, Inc.) and Roxanne Feige (Atkins Global) served as Co-Chairs of the WTS-DC Mentoring Committee in 2020. Sara Henly-Thomas (HDR) provided support as a volunteer.

Sixteen mentor-mentee pairs participated in the 2020 program. Applicants were matched based on their work experience, interests, sector of employment, and personality-communication style. Each pair was encouraged to meet at least once a month on their own and attend group events throughout the program. Monthly check-in surveys were completed by mentors and mentees to ensure the pairs were continuing to build their partnerships and were meeting regularly. Doodle polls were used to select the best available date to host events.

Due to the COVID-19 pandemic, the mentoring events were held virtually. Mentor-mentee pairs attended a kick-off meeting on March 23. The committee hosted a virtual happy hour in May, where participants played several rounds of ice breaker questions using a dice to determine which question each person would answer. Other virtual happy hour events were held in July and September via Zoom. During these events, the group hosted transportation/DC trivia and two rounds of two truths and a lie (one round being professional theme and the other personal).

In June, the committee hosted a professional development event featuring Sharon Podobnik Peterson, the founder of The Center for Conscious Leadership and The Go Love Yourself Box, a subscription box for personal growth. Sharon prepared a presentation about Communication Styles while working from home. In August, the committee hosted a group event focusing on Difficult Conversations. Chris Vineis, one of the founders of WTS and the President of Capital Partnerships LLC, moderated the conversation.

The last event of the 2020 program was a panel discussion on tips for success in the transportation industry. The panel included speakers from the private and public sectors. It was open to all WTS-DC members and non-members.

Professional Development Committee

The Professional Development Committee provides opportunities for members and non-members to advance their careers through educational, informative, and skill-developing events. They collaborate with other committees to organize joint events to support career development.

In 2020, Cerasela Cristei (EXP) and Khatereh Vaghefi (WSP USA) served as the Chair and Deputy Chair, respectively, of the Professional Development Committee. Maha El-Metwally (JMT) provided support as a volunteer.

The committee started the year strong with plans to organize several Professional Development events and an annual bike tour to raise funds for the WTS-DC Scholarship Fund. In February 2020, the committee organized an in-person professional development event, called “Visual Resume,” featuring professional wardrobe stylist and image consultant Robin Finnell. Ms. Finnell provided invaluable information to our members on creating a personal brand and a wardrobe style appropriate for the corporate ladder.

Following the start of the pandemic, however, the committee adjusted its goals to serve the needs of WTS-DC members. The committee assisted the Diversity Committee in developing a survey to reach out to members and evaluate the impact of COVID-19 on jobs in the transportation industry, on women and on their families. The committee also modified its annual Virginia Department of Transportation (VDOT) workshop to “go virtual.” The collaboration between the Northern Virginia District of VDOT and the WTS-DC Chapter resulted in another successful event. High-profile speakers discussed the impact of COVID-19 on VDOT’s operation, budget, and staff. VDOT also gave an update on major projects, which maintained their progress during the pandemic and achieved major milestones.

Program Logistics Committee

The Program Logistics provides support to other committees and groups who are hosting Chapter events. They support event organizers by helping to identify venues and caterers, and by providing advice on contracts. The committee works with the event planning committees, assists with planning the events and with catering and venue coordination when required for in-person events. The committee arranges registration on Eventbrite before events. For in-person events, the committee handles name-tags, registration, and works with walk-in attendees to purchase tickets at or after the program and assisted with event set-up.

The Program Logistics Committee was led by Katie Masetti (Mead & Hunt) as Chair, and Sophie Guiny (InfraStrategies, LLC) as Deputy Chair, Ellie McCurdy (VHB), Elizabeth Patel (US FHWA), and Daisy Allman (Alexandria Transit Company/DASH) supported the committee as volunteers.

As with all committees, the Program Logistics Committee had to adjust to the new paradigm of virtual events. While the committee still managed the Eventbrite pages for virtual events, they also worked with the planning committees to ensure Zoom meeting information was e-mailed to registrants before the event. The committee members attended tech run-throughs for applicable virtual events when the WTS-I Zoom account was used.

The committee worked with the Membership Committee to ensure that those who purchased member tickets are members in good standing of WTS. After an event, the committee reports on event metrics at the following board meeting.

In 2020, the committee supported all WTS-DC events listed in Table 7 below, except those events hosted jointly with other local professional organizations.

Recognitions Committee

The Recognitions Committee is responsible for handling the Chapter's solicitation, nomination, evaluation, and certification of its annual awards.

The 2020 Recognitions Committee was led by Haley Peckett (DDOT) as Chair and Jamie Rosen (Kimley-Horn and Associates) as Deputy Chair.

The Recognitions Committee enabled WTS-DC to recognize six deserving individuals, projects, and companies that have advanced women in transportation. Early in the year, the committee updated its

electronic records of past Recognition Award recipients in the WTS-DC Dropbox files for future institutional knowledge.

In May 2020, the committee developed and posted updated nominations forms using Google Forms and started publicizing the nomination period, which ran through June 30, 2020. After receiving several nominations, the committee recruited six WTS-DC Board Members to serve on an evaluation panel and set up a matrix in Excel to review each panelist according to 2-5 criteria (the criteria vary by award category). The panel reviewed the nomination forms in August and presented their recommendations to the Executive Board and full Board in September.

The Google nomination form, scoring matrix, and some marketing materials created this year can easily be repurposed for future years.

The Recognition Award recipients received their awards virtually at the WTS-DC Holiday Party on December 8, 2020. (See “Recognition Awards” section below for more information on these deserving award recipients.) The Committee arranged for each of the award recipients to record a video to be shared during the virtual award ceremony. The award recipients received their physical awards by mail prior to the Holiday Party.

Each of the six WTS-DC Recognition Award recipients was nominated in their respective award category at the WTS-I level. As a final note, one of the WTS-DC recognition award recipients from 2019 rose above the competition at the international level. Paul Skoutelas, CEO of the American Public Transit Association (APTA), received WTS International's Honorable Ray LaHood Award for 2020. Paul accepted his award virtually during the WTS-I Annual Conference in May 2020.

Scholarship and Fundraising Committee

The Scholarship and Fundraising Committee is responsible for both awarding scholarships and raising funds for scholarships. Each year, the committee plans the calendar year for the annual scholarships, seeks out potential applicants, convenes the review panel, seeks Board approval of the scholarship recipients, and notifies the recipients and coordinates with them on the logistics of accepting their awards. The committee is also responsible for coordinating complimentary membership for awardees and for completing the WTS-I scholarship applications.

In 2020, the Scholarship and Fundraising Committee was chaired by Shelley Wynne (Dewberry). Alanna McKeeman (Foursquare ITP) served as Deputy Chair. Ruby Lee (WSP USA) volunteered as a committee member.

The Scholarship and Fundraising Committee encourages young women to advance their educational and professional career in transportation by providing networking and learning experiences through a one-year free membership. The committee is responsible for both awarding scholarships and raising funds for scholarships. The committee collaborates with almost all the other Board committees to raise funds, create awareness, and retain past recipients as members.

The committee issued a call for scholarship applications to regional colleges and universities in the Washington, DC metropolitan area in early fall 2020. The committee continues to add to its existing contact list of colleges and universities to increase the diversity of the applicant pool of applicants. The committee received impressive applications in 2020. After convening a scholarship review panel, the committee recommended that nine, highly qualified students receive WTS-DC 2020 Scholarship awards ranging in value from \$1,000 to \$2,000. The recommendation was presented to the WTS-DC Board in October, and the nine recipients were confirmed. In all, WTS-DC provided scholarships totaling \$15,500 in 2020, which is the highest amount the chapter has ever distributed.

The 2020 scholarship recipients were recognized virtually at the WTS-DC Holiday Party in December 2020. (See “Scholarship Awards” for more information on these deserving recipients.) The scholarships were awarded after a year’s worth of fundraising events and donations. The committee did not set a specific fundraising goal for 2020 for the WTS-DC Scholarship Fund. Instead, their efforts focused on increasing the number of applicants received in 2020, which involved a thorough update of the college and university contact list. Funds were raised through collaboration with other committees this year. Additionally, the committee obtained three Named Scholarships, valued at \$2,000 each, from corporate sponsors Dewberry, HDR, and WSP USA. Kimley-Horn generously donated \$2,500 and Cardinal Infrastructure provided a \$300 donation to the WTS-DC Scholarship Fund. The fundraising sources are listed in Table 5 below.

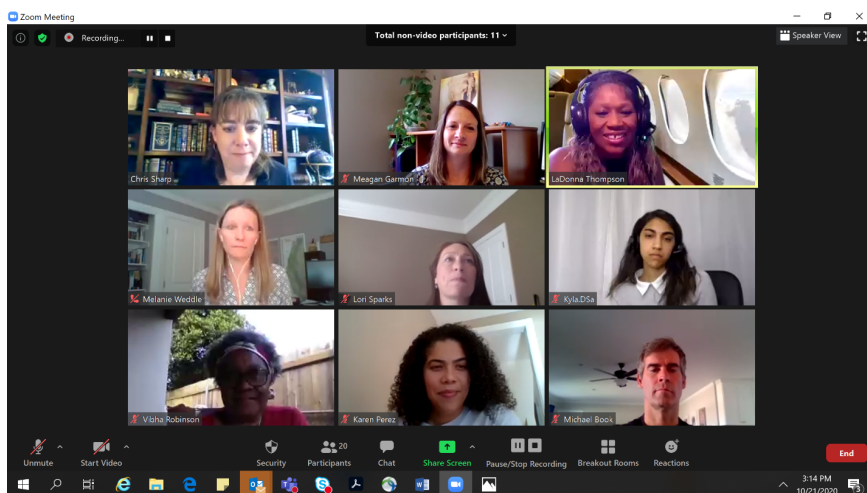

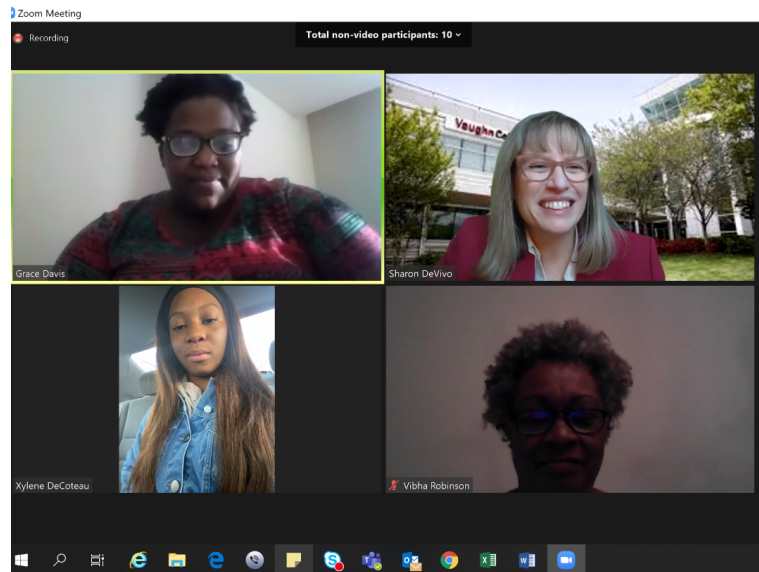

Executive Women’s Roundtables

President Neela Babu organized two Executive Women’s Roundtables (EWR) in 2020 -- for the first time as virtual events!

On May 15, WTS-DC hosted the first EWR session of 2020, titled “Leading Through Times of Uncertainty: Keeping People & Strategies at the Forefront.” The session was facilitated by Teri Fischer, a speaker and executive coach who is the CEO and Managing Partner of Insight Strategies, Inc., and focused on how we lead during crises, such as the coronavirus pandemic. The session recognized that while all of us know how to do our jobs, women are being tested as people and leaders of teams, departments, organizations—and even their families. Fisher’s message emphasized that women leaders can choose to shrink or go big. They can choose to have a victim mindset or lead from a place of hope and accountability. Teri challenged the

participants to ask themselves about the choices they would make. WTS-DC would like to thank Insight Strategies for generously donating this event.

WTS-DC continued its Executive Women's Roundtable (EWR) virtually with another session held November 13, titled "Communication in a 21st Century Workplace: Is it evolving beyond my capabilities?" Attendees discussed the latest communication technologies and their comfort level with them, asked questions of the communications experts, and shared their own experiences, including lessons learned. They appreciated the insights on how to create social media posts and how to mine the analytics. The discussion focused on the four primary social media platforms currently used by the business community: Twitter, Facebook, Instagram, and LinkedIn. Our communications experts, from KGL Communications and Sharp & Co, explained how these social media accounts should be managed and how to create marketing campaigns to reach specific audiences. WTS-DC thanks KGL Communications and Sharp & Co for generously sharing their expertise with our group!

These invite-only events bring together top-ranking women in the transportation industry in a facilitated forum to interact, network, and discuss common issues. The women who participate in the events include attendees from the public, private, and non-profit sectors. Typical invitees include women who are Executive Leader Members of WTS, women who are in leadership positions within Corporate Member companies and organizations, and women in leadership roles in the D.C. transportation community.

Transportation Trivia: A Night of Social Distancing Fun

On June 11, WTS-DC hosted a trivia event and invited our audience to engage in an hour of virtual fun and networking. Thirteen WTS-DC members and friends convened for the virtual trivia event.

Five teams of two joined in on the fun with three moderators/scorekeepers. WTS-DC Past President Adrienne Ameel and Board Advisors Margaret Ballard and Avital Barnea developed and read the questions and answers, which included two verbal rounds and one picture round.

Questions ranged from "What is the only underground WMATA Metrorail station that has high speed elevators but no escalators to access the surface?" (answer: Forest Glen) to "In 1997, who was the first female appointed to lead the Federal Aviation Administration?" (answer: Jane Garvey) to "The Arc de Triomphe, one of the most famous monuments in Paris, France, has how many avenues radiating from its central plaza?" (answer: 12).

For the final question, teams were able to wager up to their total number of points accrued through the first three rounds. The category of the final question was "U.S. Airports" and teams had to come up with the correct three-letter codes for five major airports across the country (Portland, Phoenix, Minneapolis-St. Paul, Newark, and Orlando). Teams had to correctly name all five three-letter codes to claim any points. The final question ended up tumbling two teams down to zero points, but three teams knew all five airport codes, allowing one team to double their score.

Despite having to stay at home and social distance, participants agreed that the night provided a creative way to network, learn some random transportation facts, show off people's obscure transportation

Take a Breath: An Evening of Mindfulness with Pause Breathwork Instructor Tanya Saunders

On June 17, WTS-DSC hosted Pause Breathwork Instructor Tanya Saunders, who invited participants to take time out to breathe, connect, release, and transform their minds and bodies during this difficult time. Tanya guided participants through a meditative breathwork journey set to music to breathe, feel, heal, and thrive.

Created by Founder and CEO Samantha Skelly, the Pause Breathwork breathing method uses various, continual breath patterns to break down emotions in the body that stay stuck and create stress in our energetic bodies. Coffee Chat with FAA's Pam Whitley

On July 21, WTS-DC held a coffee chat with Pamela Whitley, Acting Assistant Administrator for NextGen (ANG) at the Federal Aviation Administration (FAA). This coffee chat was designed for a small group of attendees to sit around a virtual table with Whitley and engage with her in a conversational format. Twenty WTS members and friends joined us for this event.

Whitley discussed the NextGen program. The Next Generation Air Transportation System (NextGen) is the FAA-led modernization of America's air transportation system to make flying even safer, more efficient, and more predictable. Whitley shared how the NextGen program was created by Congress in response to congestion and delays in the national airspace system. Congress created a joint organization to look at the problem and Whitley led that effort.

Throughout her career, Whitley volunteered to take on new tasks and, as an engineer, she always looked for ways to solve problems. When taking on a new role, she pursued opportunities that she believed would expand her skill set and help her reach her personal goals. When asked about her leadership

experience, she discussed the importance of building relationships and meeting people. She also mentioned the value of guiding people and having them take ownership of their work. Her leadership strategies have allowed her to develop a team of people who respect her and respond to her requests.

Attendees were grateful for this opportunity to chat with Whitley and WTS-DC is thankful for her willingness to join us.

From Grounded to Take-Off: A Discussion on Domestic and International Aviation Recovery – An Event Hosted Jointly with YPT-DC and TRF



Joint Event with TRF-DC and TRF

For the 11th year in a row, the Transportation Research Forum (TRF-DC), WTS Washington, D.C. Chapter (WTS-DC), and Young Professionals in Transportation (YPT-DC) partnered to host “From Grounded to Take-Off: A Discussion on Domestic and International Aviation Recovery.” The virtual discussion examined the impact of COVID-19 on domestic and international travel as well as the steps that countries, airlines, and airports are taking to ensure a safe, secure, and resilient air transportation system. The panel of industry

experts discussed the role that their respective organizations have played in safeguarding the flying experience and provided insights on how public health fits into long-term recovery strategies.

Listeners enjoyed hearing from Carey Fagan, Director of the Asia-Pacific Region, Federal Aviation Administration, Dr. Ansa Jordaan, Chief of the Aviation Medicine Section, International Civil Aviation Organization (ICAO), and Annie Russo, Senior Vice President of Government and Political Affairs, Airports Council International-North America. Peter Cerda, Regional Vice President of the Americas, International Air Transport Association (IATA), moderated the discussion.

The lively conversation began with a summary of the pandemic’s impact on the aviation industry and experts’ best estimates of the “time to recovery” (to 2019 levels) for domestic and international air traffic. The panelists emphasized that the “new normal” of the pandemic has brought about a drastic change in passenger behavior and the need for the aviation industry to work together to put passengers back in the air. During the question-and-answer, the panelists agreed that the biggest challenges facing the industry are two-fold: harmonizing the industry’s approach to air travel after the pandemic and ensuring that passengers understand the measures in place to make air travel as safe as possible for the consumer.

Coffee Chat with Chris Conklin, Director of Montgomery County Department of Transportation

On September 10, WTS-DC hosted a coffee chat with Chris Conklin and Hannah Henn to discuss how Montgomery County Department of Transportation (MCDOT) is responding to the pandemic. Chris Conklin is the Director of MCDOT, and Hannah Henn serves in two roles as Acting Strategic Communication Manager and Senior Engineer for Strategic Innovation in the MCDOT Office of the Director. WTS-DC and MCDOT were joined by 27 members and friends, making the conversation very lively.

Conklin and Henn started the conversation with an interesting presentation discussing an overview of the many innovative initiatives the county is taking to respond to the pandemic. The presentation covered how the county was able to navigate funding through the Cares Act, its Shared Streets initiative, parking enforcement, the COVID Corps Youth Program, Safe Routes to Schools, and changes in transit services in the county.

MCDOT discussed how they approached the challenging task of reducing and modifying transit routes in the county. The county ensured that all of the bus routes still connected communities to essential services such as grocery stores, hospitals, and banks. MCDOT focused their attention on making sure that transit dependent communities were still being served. They also included a map to show residents how they could access essential services and other routes that may be available to them. The county was one of the first to enforce a rear-door bus boarding policy, to require masks to be worn, and to provide masks to customers. The county worked hard on sanitizing all of the buses every day to make citizens feel comfortable with riding the bus.

MCDOT discussed the innovative COVID Corps Youth Program deployed during the pandemic. The summer employment program provided young residents an opportunity to support the county's response to the COVID-19 pandemic. Some of the services the program offered specific to MCDOT included providing information to the community about changes in transit service and educating the public on scooter and bike safety and etiquette.

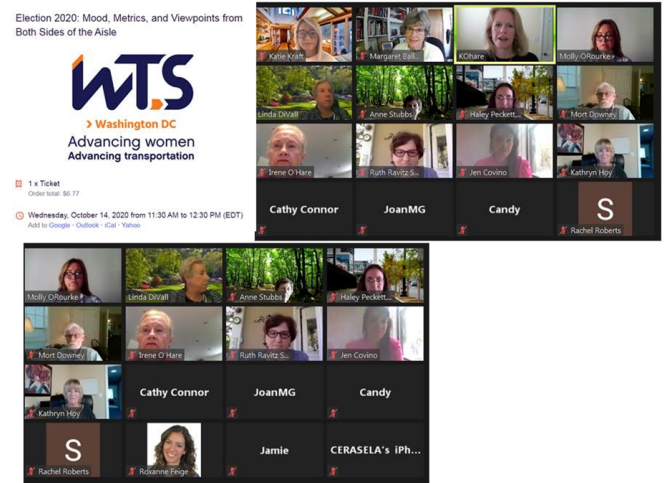

Election 2020: Mood, Metrics, and Viewpoints from Both Sides of the Aisle

In October, the Legislative Committee organized a virtual webinar about the upcoming election and related demographics. Two highly respected individuals in public opinion research offered key insights. Linda DiVall, a Republican pollster, and Molly O'Rourke, a Democratic pollster, provided their professional expectations into the Senate, House, and presidential races. Ms. DiVall is the founder and Executive Chairman of American Viewpoint; Ms. O'Rourke is a partner at Hart Research. Kerry O'Hare (O'Hare Infrastructure Strategies, LLC), Deputy Chair of the Legislative Committee, moderated a robust conversation about polling and the 2020 election, including lessons learned from 2016.

Vision Zero: Transportation Safety in the DMV

On October 21, WTS-DC hosted representatives from Montgomery County, DDOT, the City of Alexandria, Arlington County, and Prince George's County to discuss transportation safety and their adoption of Vision Zero—a programmatic strategy to reduce deaths and serious injuries on the transportation system. Dr. Laura Fraade-Blumar, an injury epidemiologist specializing in transportation at RAND Corporation, moderated the panel. During the discussion, panelists described how adopting Vision Zero has impacted their respective jurisdiction's approach to responding to safety concerns, implementing projects, prioritizing equity, and adjusting to new circumstances in a global pandemic. The following key themes emerged throughout the hour-long conversation:

- Through the implementation of their Vision Zero programs, each agency has enhanced their data collection, review, and analysis efforts to inform decision-making. Vision Zero's safe systems approach means using data to proactively address safety issues—preventing crashes before they happen. Panelists added that making crash data available to the public promotes transparency in this process.
- Top-down support from officials and jurisdictional leadership is paramount to the success of Vision Zero programs. Identifying transportation safety as an agency priority gives program staff the ability to go bolder and spark the organizational change needed to move safety projects and policies to the forefront.
- Vision Zero has provided a platform for agencies to enhance internal collaboration practices, moving the transportation safety conversation outside of just engineers and planners to engage staff from disciplines such as public health, police, parks/recreation, land use, and public safety. Panelists

emphasized that Vision Zero has helped to enhance coordination across these departments and break down silos to create a unified approach to transportation safety.

- Equity is the cornerstone to Vision Zero. Panelists described how they integrated equity metrics into their project evaluation and selection criteria to address underserved areas or vulnerable populations. Panelists also emphasized the importance of making their public engagement efforts accessible to people of all abilities, ages, languages, incomes, races, ethnicities, and neighborhoods.
- The Vision Zero program coordinators at each regional jurisdiction meet monthly to discuss ongoing activities and plans. This has created a new avenue to collaborate and share lessons learned, which has been extremely valuable, especially for cross-border issues.

Over 50 attendees logged in to the virtual panel bringing excellent questions and perspectives to the conversation. We thank those who attended and helped to raise over \$300 for the WTS-DC scholarship fund! For more information on Vision Zero, please visit the [Vision Zero Network](#).

WMATA During the Pandemic

- WMATA immediately focused its priorities on the most critical challenges: safety of the workforce and customer; aligning service with demand, especially for essential service and the transit-dependent; service equity; and protecting the system’s future as a critical transportation and economic asset for the region’s recovery.
- Planning, preparedness, regional partnerships, and communication were central to WMATA’s response to the operating challenges.
- A similar reliance upon regional collaboration and communication – with its board and workforce and with other transit agencies and organizations – guided WMATA’s steps to deal with the financial fallout of the pandemic.

Acknowledging WTS’s focus on professional development for women in transportation, Ms. Impastato and Ms. Sullivan also shared lessons learned from their own career paths. They spoke about unexpected

experiences in one's work life that can offer risk as well as opportunity for professional growth and career development. Remaining curious and saying "Yes" to such opportunities can lead to personal and professional growth. If public service is recognized as a calling, being open to such opportunities can be educating and rewarding at any level.

Once again, the WMATA event was one of the Chapter's most popular (well-attended) with nearly 90 participants who engaged with a variety of questions. In addition to being informative, the webinar generated almost \$1,500 for the WTS-DC Scholarship Fund.

In 2020, WTS-DC honored ***District of Columbia Mayor Muriel Bowser*** with the Chapter's Rosa Parks Diversity Leadership Award for her work to create the Black Lives Matter Plaza on our very own District streets during tumultuous social unrest and to strengthen transportation as a way to connect District residents with opportunities.

WTS-DC honored the ***American Public Transit Association (APTA)*** as the recipient of the Chapter's Employer of the Year Award. APTA's mission is to advance public transportation, and APTA has worked hard to advance women in its organization and in the industry. APTA has been a steadfast supporter of WTS-DC and of women's professional development in transportation.

Innovation Transportation Solution Award

This award salutes an innovative transportation project led by a woman. (Only completed projects will be considered for the award.) The recipient is selected based on the following criteria: the purpose of the transportation initiative, solution, project, or policy and the number of women involved from initiation to completion; the key elements of the project and how the female project manager successfully implemented those elements; a description of how female project manager successfully met and overcame challenges; and how the project achieved its purpose.

WTS-DC honored **Open Streets DC** as the Chapter's 2020 recipient of the Innovative Transportation Solution Award. The Open Streets DC event was held in October 2019, and it re-envisioned Georgia Avenue, NW as a place for walking, dancing, bicycling, and even rock climbing. Open Streets DC supported Vision Zero as a way to pilot new transportation choices. The project manager, Anna Chamberlin, Director of DDOT's Planning and Sustainability Division, accepted the award. Chamberlin, along with several other female leaders, overcame many logistical and regulatory challenges to make the event a success.

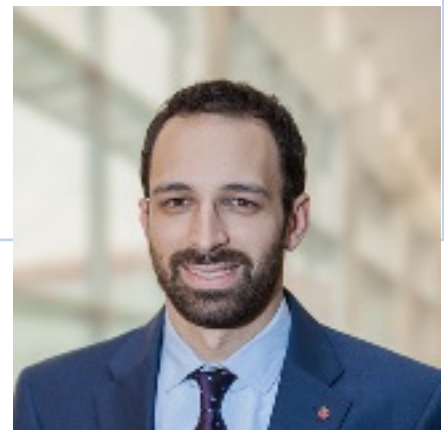

WTS International 2020 Honorable Ray LaHood Award

On May 21, WTS International recognized WTS-DC 2019 Honorable Ray LaHood awardee, **Paul Skoutelas**, CEO of the American Public Transportation Association (APTA), as WTS-DC's 2020 Honorable Ray LaHood award recipient. Through his leadership positions, Skoutelas has worked to create opportunities for women transportation professionals. In his current role, he is instrumental in continuing the strong industry partnership between APTA and WTS. Both organizations "share [a] long history of working

together and ... are aligned in supporting [the] professional development and career advancement of women,” said Diane Woodend Jones, former WTS Chair.

Skoutelas also has contributed to the advancement of women and minorities through his long involvement in WTS. He has been a member of WTS for more than 20 years, and was instrumental in the creation of the WTS chapter in Pittsburgh, and participated in Central Florida, New York, and now in D.C. Skoutelas has spoken highly of the impact WTS membership has had on his career: "WTS has helped to enlighten me about the diversity of our industry and importance of inclusion in ensuring that many talents and perspectives are at the table when making decisions." Skoutelas has been an active supporter of WTS-DC, and in 2019, headlined a breakfast event titled, "The New Mobility Paradigm: A Conversation with APTA's Paul Skoutelas," where he engaged a sold-out audience on the need for transit in increasingly multimodal world. Through WTS, Skoutelas has been able to identify and network with emerging women transportation leaders and help them to grow and develop their careers.

Since being recognized by WTS-DC in 2019, Skoutelas has stayed busy with advocacy and policy leadership related to public transit amidst one of the worst financial and transportation crises of our time. He successfully advocated for \$25 billion for transit in the CARES Act, which was signed into law to cover lost revenue. He also advocated for the House to include \$15.75 billion in the HEROES Act, which is still pending. His impactful leadership embodies all of the principles of the Honorable Ray LaHood Award: he leads through difficult times, he has made a demonstrable impact on the state of transit today, and he continues to advance women and minorities in transportation.

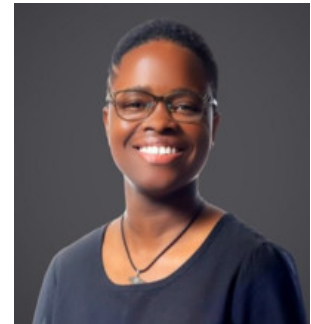
Nicole Russo

Since 2016, she has held the Graduate Research Assistant position at the Center for Advanced Transportation Technologies (CATT). She has set ambitious goals for herself to become a successful woman in academia, tackling some of the most challenging problems in the field of transportation addressing multidisciplinary issues with important financial and environmental impacts.

Other Chapter Activities

WTS International Annual Conference

In support of Chapter members' continued professional development, each year WTS-DC provides an opportunity for board members to apply for funding to attend the WTS Annual Conference. The Chapter planned to send four board members — Audra Bandy, Holiday Party Committee; Shelley Wynne, Scholarship Committee; Rachel Roberts, Treasurer; and Neela Babu, President — to the 2020 WTS-I Annual Conference in Phoenix, Arizona. Due to the COVID-19 pandemic, WTS-I decided not to hold the conference in person. Instead, WTS-I provided some of the conference's content through an online learning webinar series in September and October 2020. The Chapter offered the online webinar opportunity to Audra, Shelley, Rachel, and Neela. Audra attended for the Chapter.

WTS International Splash Party

On May 29, WTS-DC members participated in WTS International's virtual "splash party" for the Northeast Region to celebrate the new WTS brand identity and to build excitement. WTS International Executive Director Sara Stickler emceed the event, and chapter presidents were invited to give brief remarks about their chapter's uniqueness and about a memorable chapter event. Neela Babu, WTS-DC President, had the honor of speaking on behalf of WTS-DC. Neela spoke about WTS-DC's unique role in the WTS network. WTS-DC was the very first chapter of WTS! In 1977, 40 women in Washington, D.C. -- all engaged in transportation -- recognized the need for a means to enhance professional and personal

advancement in their field, and to develop greater industry and government recognition of the increasing involvement of women in the field of transportation. That original initiative gave birth to the Women's Transportation Seminar and has grown over the past 40+ years into an international organization of over 8,500 women and men. The splash party was a wonderful way to engage with women across the northeast WTS network and share stories about the impact that WTS has had on so many lives.

WTS International Chapter Leadership Training

In November 2020, WTS-I held its annual leadership training virtually due to the impacts of the COVID-19 pandemic. Despite the change, the training was still valuable and productive for many WTS members. From WTS-DC, Shelley Wynne (Scholarship and Fundraising Committee Chair), Sophie Guiny (Program Logistics Committee Deputy Chair), and Amber Garnett (Communications Committee Deputy Chair) attended. All three women enjoyed the leadership training.
