### **Chief of Staff**


Taxi Limousine Commission (TLC) is seeking a Chief of Staff, Licensing Division to work closely with the Deputy Commissioner for Licensing and Standards. The Division of Licensing and Standards ensures that those seeking to participate in the for-hire industry in New York City comply with the City's high standards for safety, fitness to serve the public, and customer service. It enforces these standards by reviewing license applicants' backgrounds and other essential requirements-such as proper insurance and payment of required taxes and fees--both at initial licensure and on an ongoing basis. It also oversees the education of new and existing drivers and operates a call center to assist licensees and the public. The Licensing Division provides these services striving to meet high standards of efficiency and customer service. Key responsibilities may include:

- Management: Assists the Deputy Commissioner in managing this 156 person division.
- Analysis: Identify opportunities to improve the efficiency and/or customer service in the Licensing Division and work with staff to implement these opportunities.
- Editing: Review documents, proposals, website material, and other communications and revise them to reflect audience-appropriate language and tone.
  Provide constructive feedback to staff to refine their project plans and proposals.
- Organization and Project Tracking: Develop systems to monitor progress of high volume of short- and long-term operational improvement projects. Requires highly proactive work style and excellent follow-up and organizational skills.
- Representing TLC's Licensing Division: Represent TLC's Licensing Division with industry stakeholders. Liaise with other TLC divisions and agencies. Coordinate with TLC's MIS Division and information technology providers to develop and implement technology upgrades.
- Research and Data Analysis: Direct and review the work of data analysts and other staff conducting performance management research and undertaking operational and customer service improvements. Research technical issues that arise in the administration of the Licensing Division to determine the best path forward.
