

I recently attended the annual Chapter Leadership Development conference hosted by WTS International in Newport Beach, California along with HOT Chapter board members Andrea Bryant (Recognitions), Laura Friello (Vice President), Seles Johnson (Treasurer), and Antionette Roberts (Gala). Together, we heard from other chapter leaders on the ways that they are leading their chapters to provide engaging and meaningful events and volunteer opportunities for transportation professionals and students across the country. We also gathered with the Texas WTS Chapter leaders present for a group photo and shared insights on how we can continue to advance transportation and women in Texas.

At that event, WTS International CEO Sarah Stickler shared the International Board's vision statement on what WTS does. WTS advances transportation, provides professional and workforce development, advocates for gender equity, pursues key legislative and policy priorities that support women and transportation, and builds the future of transportation. Hopefully, each of you, as members and active participants in WTS HOT Chapter events, can see yourself and what we do as a chapter in this statement. It is important work, and we appreciate you engaging with us to achieve it.

All members of WTS should have received an email in early December from WTS International announcing the new membership structure and rates that will go into effect on January 12, 2024. WTS International is making these changes to begin to bring the association's membership rates in line with similar national transportation associations. WTS International has begun that process with this first baseline dues increase and has planned incremental annual increases of 5% per year over the next four years. Beyond the dues increase, the changes to the membership structure move away from dues based on self-reported salary and into more streamlined and logical membership categories: student (no fee), professional (dues based on employing organizational type), executive (dues based on employing organizational type), and lifetime (for those who are retired but still wish to remain engaged with WTS and its mission). # **LATTES AND LEADERSHIP**

### July Lattes and Leadership, Lindsay Wood, PE



The July Lattes & Leadership featured Lindsay Wood, past WTS HOT Chapter President (2017-2018), who is the Executive Vice President of Engineering & Construction at Austin Transit Partnership (ATP). In her current position as Assistant Director for the Networking Modeling Center and Strategic Planning Manager at the UT Center for Transportation Development (CTR) Heidi has been working on Texas SMARTTrack, and she gave an overview of the three tiers of testing that will be available in and around the Pickle Research Center. Heidi offered some great career tips including "If you know what you're doing, you're not growing,", and "Get a mentor."







# Navigating NEPA: Insights on the Council on Environmental Quality's Phase 2 Rulemaking Process"



In October 2023, the WTS Heart of Texas Chapter hosted its monthly luncheon, featuring insights from Doug Booher, TxDOT's Director of Environmental Affairs Division, who shared thoughts on the Council on Environmental Quality's Phase 2 rulemaking process for NEPA. This comprehensive phase follows the Phase 1 rulemaking in 2021, which aimed to reverse some changes introduced in 2020 under the Trump administration. Notably, this marks a significant shift, as prior to 2020, the rules had remained stable since 1978. Stakeholders were encouraged to submit comments by the end of September 2023, with anticipation that the rules with come into effect around April 2024.

Mr. Booher shared that the proposed rules were not only becoming longer and more complex, with an approximate 15% increase in length, but also introduced several new administrative requirements. The changes suggest a trend towards making Categorical Exclusions (CEs) more akin to Environmental Assessments (EAs) and EAs more similar to Environmental Impact Statements (EISs). He shared the following proposed changes supported by him and his team and proposed changes they disagree with.



#### **SUPPORT FOR PROPOSED CHANGES:**

40 CFR 1502.9(b): The proposed revision clarifies that the decision to prepare a supplemental Draft Environmental Impact Statement (DEIS) is at the agency's discretion. This change ensures that the agency responsible for the DEIS determines whether supplementation is necessary.

40 CFR 1502.11(g): The proposal to remove the requirement to include the estimated cost of preparation on the cover of an EIS is welcomed by Doug and his team. This requirement, added in 2020, was deemed challenging to calculate due to the various internal and external staff involved over several years.

### **NOT-SUPPORTED PROPOSED CHANGES:**

Several proposed changes in the Council on Environmental Quality's Phase II Rulemaking for NEPA were met with disapproval from Doug and his team. Firstly, the instruction (40 CFR 1501.4(b)(1)) to publish CE determinations with "extraordinary circumstances" but no significant effects is critiqued for its circular definition and potential confusion amid numerous annual CEs. Secondly, the requirement (40 CFR 1501.7(a), 1501.9(c)(1)) to formally designate participating and cooperating agencies on EAs is criticized for blurring the line between EAs and EISs, potentially complicating the process. Additionally, the proposed necessity (40 CFR 1501.12) to "briefly explain the relevance of the incorporated material to the environmental document" is deemed unnecessary, as existing rules are considered sufficient. The suggestion (40 CFR 1502.14(a)) that EIS explores alternatives beyond the lead agency's jurisdiction is questioned for its potential to waste time and resources. Other not-supported changes involve issues like the removal of the provision on scientific research (40 CFR 1502.23(b)), the requirement for a ROD on mitigation (40 CFR 1505.2(c)), and the complexity of defining "environmentally preferable alternative" (40 CFR 1508.1(I)), which raises concerns about meeting multiple objectives outlined in Section 101 of NEPA.

The upcoming months are crucial as stakeholders engage in the commenting process to shape the final rules. The changes hold implications for environmental assessments and impact statements, influencing project evaluations and decision-making processes. Stay tuned for further updates as the rulemaking process unfolds!
