In February, T YOU took a field trip to the UMN campus which included tours of the UMN Energy Plant, CEGE facilities, and Nano Center, providing firsthand exposure to transportation-related studies and research. On April 1, T YOU hosted another in-person meeting, this time focusing on bridges and structures, further enriching the mentees' understanding of transportation infrastructure.


